- * Waste reception fee includes 80€/t taxes
- Reception fee is collected from the customer
- Handling and weighing aren't charged on household wastes like glass or plastic packages, metal, carton, paper and end of life textiles.
- Large soil deliveries must be settled separately.
- Waste facility personnel have the right to deviate from the handling fees if the incoming waste is more problematic than usual, or is easily recoverable or is considered to be at an unreasonable cost for the customer
- Hazardous waste delivered to hazardous waste treatment plants are charged according to facilities handling fees in accordance with the current price list plus transport and packaging costs (+10%).
- Hevossuo Waste Management Centre don't take large deliveries of hazardous waste from companies.
- The fee is charged on the basis of the waste subject to waste tax that the load mainly contains.
- A waste importer who fails to comply with the waste handling guidelines can be charged with a waste handling fee added with potential cleaning etc costs.
- Fees may be reduced or increased by 20% on the basis of costs.
